



CONTINUOUS SERVICES CONTRACT

I do hereby entrust **BARK BARN** to care for my pet(s) during their boarding stay and agree to all of the terms listed below::

I authorize the staff of BARK BARN to do whatever they deem necessary for the health and well-being of my pet(s) and agree to pay for any and all expenses relating to such care. This includes, but not limited, to any veterinarian expense we determine is reasonably necessary for any injury or illness that we determine needs immediate attention. In such circumstance, BARK BARN will transport your pet to a veterinarian of BARK BARN's choice and attempt to contact you as soon as reasonably practicable.

I agree to promptly pay the daily fees for services rendered at posted rates. I understand that if I do not cancel my reservation within 2 Days (*3 during Holidays / Peak Times*) prior to scheduled boarding, I will not receive my deposit back.

I agree that I am solely responsible for any damages that my pet(s) may cause through malicious or improper conduct. These damages may include dog suites, kennel, or home destruction. Or an injury to a human and/or pet through malicious or aggressive behavior.

I understand the risks involved in socializing my pet(s) in an In-Home care facility and I agree to release BARK BARN and its owners, agents and employees from any and all liability claims resulting from any and all injuries that may occur as a result of socializing my pet(s).

I understand that if my pet is picked up after Check Out time, which is 12:00 pm *Monday-Friday* and 4:00 pm *Sunday*, I will be responsible to pay a \$10 Daycare fee per pup. Furthermore, I understand that 6:00 pm is the latest I can Pick Up. After that, I will be charged for another Nights Fee and will need to make arrangements to pick up my pup(s) the following day. * Holidays & Peak Times May Differ. *

I agree to provide Vet Documentation showing current vaccinations for my pet(s).

Including:: **DHLPP, Rabies, Bordetella & Influenza** {Influenza is not required, but Highly Encouraged}

If your pup is long over-due on vaccinations, we will require them to be administered at a minimum of one week before arrival at BARK BARN. Puppies must be at least 4 Months of age to board, with completion of Full Vaccination series; *including Rabies & Bordetella*. We do reserve the right to refuse pets lacking proof of current vaccinations. Should your pet contract Kennel Cough (*or other common virus, etc.*) you agree to release BARK BARN from liability, as this disease is an airborne one and cannot be detected until symptoms are present.

Unsterilized pets have the tendency to play in a gender-related manner, and, in some instances, display more aggressive behavior than sterilized pets. We reserve the right to separate the unsterilized pet from playgroup. Due to the nature of our off-leash program, unspayed females who go in to "season" will be transported to the client's (or BARK BARN's choice) veterinarian for boarding. It is required that Males are Neutered by their 1st Birthday (or shortly after.) Females that have had their 1st Heat Cycle will not be able to stay with us until they've been Spayed.

The staff of BARK BARN reserves the right to make the determination of what constitutes overly aggressive play or non-social behavior. The pet(s) in question will still receive playtime and human interaction but will have its canine interaction periods restricted to make program safe for all boarding and daycare guests.

We make great efforts to ensure that all of our guests have a safe and nurturing environment. Occasionally accidents happen. We continuously monitor the play of all of our guests as well as their physical well-being. If we discover that your pet has been injured, we will notify you when you pick up your pet, or sooner, if the circumstances warrant. Additionally, each pet is thoroughly checked for obvious physical injury at the time they arrive and again before they are released to you. While we believe that we would be aware of any injury and would alert you, if you believe that your pet was injured during his or her stay, please bring it to our attention immediately at the time you pick your pet up. After your pet leaves the premises, there is no way to determine where or how your pet was injured.

I understand and agree that any amounts owed to BARK BARN pursuant to this Agreement, including, but not limited to amounts owed for services and goods provided by BARK BARN or reimbursements owed to BARK BARN for services provided by veterinarians, shall be paid immediately to BARK BARN.

I have read this Agreement in its entirety and I understand this Agreement and agree to be bound by its terms, and I acknowledge that I have been provided a copy of this Agreement.
